Sealed Bids for Zoar Road Improvements REBID will be received by the Village of South Lebanon at the Village Municipal Building, 99 High Street, South Lebanon, Ohio 45065, until Tuesday, July 28, 2015 at 2:00 p.m. local time, at which time bids received will be publicly opened and read.

In general, the project consists of the bank stabilization of Zoar Road utilizing a drilled pier wall, made necessary by a recent landslide. Grinding and overlaying approximately 0.25 miles, full-depth pavement repair, and striping are also included in this project.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.
