A RESOLUTION APPROVING AND ACCEPTING FOR PUBLIC MAINTENANCE MARY LANE EXTENSION, PIKE STREET, AND ILENE AVENUE IN WOODKNOLL SUBDIVISION SECTION 2, IN THE VILLAGE OF SOUTH LEBANON AND DECLARING AN EMERGENCY

WHEREAS, by letter dated September 11, 2015, the Village Engineer has inspected and verified that the following streets in Woodknoll Subdivision Section 2 have been constructed in compliance with the approved plans and the Village's Subdivision Regulations Sec. 15.20.7 [Requirements for the Construction of Improvements], paragraph 6 [Inspection], to-wit:

- **Section 4**. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.
- **Section 5.** That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare.

Section 6. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
