**A RESOLUTION APPROVING AND ACCEPTING FOR PUBLIC MAINTENANCE MARY LANE EXTENSION, PIKE STREET, AND ILENE AVENUE IN WOODKNOLL SUBDIVISION SECTION 2, IN THE VILLAGE OF SOUTH LEBANON AND DECLARING AN EMERGENCY**

**WHEREAS**, by letter dated September 11, 2015, the Village Engineer has inspected and verified that the following streets in Woodknoll Subdivision Section 2 have been constructed in compliance with the approved plans and the Village's Subdivision Regulations Sec. 15.20.7 [Requirements for the Construction of Improvements], paragraph 6 [Inspection], to-wit:

Street Name	Street Width	Street Mileage
Mary Lane Extension	29.00'	642 lf.
Pike Street	29.00'	440 lf.
Ilene Avenue	29.00'	150 lf.

**WHEREAS**, at its meeting held on September 14, 2015, the Planning Commission of the Village of South Lebanon found that the public streets and appurtenances in Woodknoll Subdivision Section 2, as described herein, have been constructed in accordance with Sect 15.20.7(6)(a-e) of the Village Subdivision Regulations; and,

**WHEREAS**, immediate action is required for the Village to accept for public maintenance of the said streets to assure such are properly maintained and open to the public, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of South Lebanon, Ohio, at least a majority of all members elected thereto concurring:

**Section 1.** That the Council approves and accepts for public maintenance the streets as described herein and illustrated on the attached map Exhibit .

**Section 2.** That the Fiscal Officer certify a copy of this Resolution to the Warren County Engineer.

**Section 3.** That the Council is acting in its administrative capacity in adopting this Resolution.

**Section 4.** That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

**Section 5.** That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare.

**Section 6.** That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
