A RESOLUTION TO INITIATE A ZONING MAP AMENDMENT FOR THE PROPERTY LOCATED AT 383 SOUTH MAIN STREET (PARCEL#12-01-401-005) CONSISTING OF 0.3256 ACRES FROM RFP [RESIDENTIAL FLOOD PLAIN DISTRICT] TO B-1 [NEIGHBORHOOD BUSINESS DISTRICT], AND DECLARING AN EMERGENCY

WHEREAS, the property located at 383 South Main Street was zoned Residential Flood Plain since the Village Zoning Code was adopted, however the property was grandfathered in as a non-conforming use for business use; and,

WHEREAS, the Village Comprehensive Plan, adopted on September 3, 2015, designates said property as a neighborhood business use along the Little Miami Scenic Bike trail; and,

WHEREAS, according to Village Ordinance No. 2012-22, due to the property not being used for a business purpose for longer than six months, the property lost its non-conforming use; and

WHEREAS, per Section 15.7.3 (1) of the Village Zoning Code, Village Council, by adoption of a resolution, may initiate an amendment to the Zoning Code; and

WHEREAS, immediate action is required to refer this action to the Village Planning Commission and proceed with the rezoning process, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

<u>Section 1</u>. That the Council hereby initiates a zoning map amendment for 383 South Main Street (Parcel# 12-01-401-005) from RFP [Residential Floodplain District] to B-1 [Neighborhood Business District].

<u>Section 2.</u> That the Village Administrator is directed to forward this request to the Village Planning Commission.

<u>Section 3.</u> That the Council is acting in its administrative capacity in adopting this Resolution.

<u>Section 4</u>. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.


Subject: 496 Mary Lane

At the last Council meeting, we discussed the property located at 496 Mary Lane. This is a dilapidated property that has been vacant for over ten (10) years. The Warren County Treasurer has foreclosed on the property for unpaid property taxes. On 4/17/17, the property failed to sell with a starting bid of \$11,500. It is scheduled for auction again on June 5 with a starting bid of \$12,000.

If the property fails to sell on the 2nd try, it would go on the forfeited land sale list. After speaking with the County Treasurer's office, the earliest this property would be available to be claimed by the Village would be next spring. If the Village claimed it then, we would still be responsible for the back taxes which are currently over \$9,000.

Also, this property would be eligible for demolition through the County's Neighborhood Stabilization Program (NSP). There would not be a lien on the property due to the size of the lot. The value of the demolition including asbestos abatement would probably be over \$10,000.

Parameters for NSP Demolition Program

Eligible properties must have all the following qualifications:

- *The lot/structure must be in Warren County.
- * Property owner cannot be over income qualification 120% LMMI
- *The structure must be residential or used for residential purposes within the last 50 years. Residential means houses, apartment buildings and complexes, group homes, transitional housing, homeless shelters and domestic violence shelters. It **does not** include hotels, motels, public facilities such as schools, hospitals, commercial buildings, industrial structures, agricultural facilities,
- *The house must currently be vacant and have been vacant for at least the previous 90 days with verifying documentation.
- *The house must be condemned or blighted as per the Warren County Board of Health, or the local Building Department, or the local Zoning Department, or the Local entity that has authority as per their structure of government, and judgment from court*.
 - *May have home owners written permission in lieu of judgment from court.

Lien is not put on property:

- * If the lot is not able to be "improved" after demolition (due to, for example but not limited to, size of lot, location of lot, no foreseeable availability of utilities). Local entity must sign off that property is not developable; and
- *Owner's household income is less than 100% AMI

or

* If the lot is owned by a local government entity (city, village, township)

Owner must sign for Lien to be put on property for value of demolition:

- *If lot qualifies to be improved after demolition is complete, or
- *If ownership conditions are objectionable, or
- *If land owner is 100% 120% AMI,

Terms of Lien: No payments/no interest for the term of the loan

Loan to be paid in full in accordance with the following recapture schedule:

- *Demo cost < \$12,000 = repayment in 10 years (\$1,200/year = \$100/month)
- *Demo cost is \$12,000 > \$30,000 =repayment in 15 years (\$2,000/year = \$167/month)
- *If the property is sold or deed transferred before the 10/15 (respectively) year term is reached.

- (c) Any operator of an establishment and any agents or employees of any operator who shall violate the provisions of Section IV, shall be fined not more than one hundred (\$100.00), together with costs.
- <u>Section 4</u>. That the Council is acting in its administrative capacity in passing this Resolution.
- <u>Section 5.</u> That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.
- <u>Section 6</u>. That it is found and determined that all formal actions of the Council concerning and relating to passing this Resolution were adopted in an open

meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
