AN ORDINANCE APPROVING ZONING MAP AMENDMENTS TO CERTAIN PROPERTIES IN THE VILLAGE OF SOUTH LEBANON, CONSISTING OF 0.3256 ACRES FROM RFP [RESIDENTIAL FLOOD PLAIN DISTRICT] TO B-1 [NEIGHBORHOOD BUSINESS DISTRICT], AND DECLARING AN EMERGENCY

WHEREAS, per Resolution No. 2017-27, the Village Council initiated a zoning map amendment for 383 South Main Street (Parcel# 12-01-401-005) consisting of a 0.3256 acre parcel from RFP [Residential Floodplain District] to B-1 [Neighborhood Business District]; and,

WHEREAS, in accordance with Section 15.7.7 of the Village of South Lebanon Zoning Regulations, on September 5, 2017, the Village Planning Commission, heard the aforementioned Rezoning Application and issued its recommendation to the Village Council that the zoning amendment be granted, as requested; and,

WHEREAS, in accordance with Section 713.12 of the Revised Code and Section 15.7.8 of the Zoning Regulations, the Village Council scheduled the Rezoning Application for a public hearing; and,

WHEREAS, the Village Council held the public hearing on October 26, 2017 at 6:30 P.M., after publication and other proper notice thereof, to consider the recommendation of the Planning Commission; and,

WHEREAS, upon considering the recommendation of the Planning Commission, a copy of which is incorporated by reference herein, and being no persons present to give testimony during the public hearing, the Council finds the process has been in accordance with Article 7 [Amendment Procedures], and adopts the recommendation of the Planning Commission; and,

WHEREAS, immediate action is required to take action within thirty (30) days after the above public hearing as prescribed in Section 15.7.11 of the Zoning regulations, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Lebanon, Ohio, at least three-fourths of all members elected thereto concurring:

<u>Section 1</u>. That the Council does hereby amend the official Zoning Map of the Village of South Lebanon, Ohio, as follows:

VILLAGE OF SOUTH LEBANON, OHIO ORDINANCE NO. 2017-13

AN ORDINANCE TO AUTHORIZE THE MAYOR TO JOIN A COALITION OF MUNICIPALITIES RETAINING SPECIAL COUNSEL FOR PURPOSES OF INITIATING LITIGATION TO CHALLENGE THE CONSTITUTIONALITY OF AMENDMENTS TO CHAPTER 718 OF THE OHIO REVISED CODE RELATING TO MUNICIPAL INCOME TAX, AND DECLARING AN EMERGENCY.

WHEREAS, the Village of South Lebanon recognizes, as a home rule power of local self-government, that municipal income tax administration and collection is vital to the health, safety and welfare of the municipality; and

WHEREAS, the Village of South Lebanon relies on the revenue from effective municipal income tax administration and collection to provide the services that maintain the health, safety and welfare of the municipality; and

WHEREAS, the Ohio General Assembly has attempted to assert control over the administration and collection of municipal income taxes by claiming that a municipality has no authority to impose an income tax unless it adopts a code in strict compliance with R.C. Chapter 718; and

WHEREAS, the established law of Ohio is clear that any such preemption of municipal income tax codes by the State of Ohio violates the Ohio Constitution and home rule provisions that allow a municipal corporation the right to administer and enforce its own municipal income tax; and

WHEREAS, more specifically, the State of Ohio has enacted HB 5 in 2014 comprehensively rewriting the entire municipal income tax law and HB 49 in 2017 authorizing centralized collection by the State of Ohio of municipalities' net profits taxes; and

WHEREAS, the Village of South Lebanon desires to assert its home rule authority to control the administration and collection of the municipal income tax, in order to provide for the health, safety and welfare of the municipality; and

- **WHEREAS**, immediate action is required to join the litigation prior to filing and before HB 49 goes into effect, and in order to preserve the public peace, health, or safety of the Village.
- **NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected hereto concurring:
- <u>Section 1:</u> The Mayor is authorized to join a coalition of municipalities being formed for the purpose of initiating litigation to challenge the constitutionality of amendments to Chapter 718 of the Ohio Revised Code contained in H.B. 5 and H.B. 49, and retain the law firm of Frost Brown Todd LLC as special counsel for the coalition of municipalities.
- <u>Section 2</u>: This Ordinance shall be an emergency measure necessary for the preservation of the health, welfare and safety of the residents of the Village of South Lebanon, Ohio, such emergency arising from the need for immediate judicial proceedings given that the effective date of Am. Sub. HB 49 is January 1, 2018;
- <u>Section 3</u>. That the Council is acting in its administrative capacity in accordance with Ohio Rev. Code § 733.48.
- <u>Section 4</u>. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.
- <u>Section 5</u>. That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.
- <u>Section 6</u>. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Subject: Emergency Pump Replacement at Main Lift Station

Recently, the Henry P. Thompson Co., while performing scheduled maintenance on our lift stations, discovered that one of the pumps in the main lift station was in need of repair. In evaluating this pump, it was brought to our attention that the three (3) pumps in this station were installed in the mid 80's. The maintenance costs continue to rise on these as the replacement parts become more expensive and more maintenance is required.

We are currently getting quotes to replace the pumps. The lowest quote to date is \$63,971 which includes the labor and 100 ft power cable.

Therefore, I am recommending that we replace the broken pump immediately and bid out the replacement of the remaining two (2) pumps.
