AN ORDINANCE ADOPTING THE VILLAGE OF SOUTH LEBANON'S BACKFLOW PREVENTION POLICY, AND DECLARING AN EMERGENCY

WHEREAS, as required by Ohio Administrative Code (OAC) 3745-95, every supplier of water in the State of Ohio is required to ensure compliance with OAC rules related to backflow prevention; and,

WHEREAS, effective January 1, 2018, the Warren County Combined Health District no longer administers backflow prevention program for water systems; and,

WHEREAS, immediate action is required to ensure that a backflow prevention program is in place and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

<u>Section 1</u>. That the Council does hereby adopt the attached Backflow Prevention Policy and incorporate the same by reference herein.
