VILLAGE OF SOUTH LEBANON, OHIO ORDINANCE NO. 2020-13

AN ORDINANCE TO AMEND ORDINANCE NO. 2002-06 RELATING TO REGULATION OF COMMERCIAL AND HEAVY VEHICLES TO TEMPORARILY ALTER THE DESIGNATED TRUCK ROUTE, AND DECLARING AN EMERGENCY

WHEREAS, on June 5, 2002, the Village Council passed Ordinance 2002-06 regulating commercial and heavy vehicles; and

WHEREAS, Ordinance 2002-06 also established the ability for the Village to create a local truck route; and

WHEREAS, Section 1 of Ordinance 2002-06 defines oversize or overweight vehicles ("Oversize Vehicles");

WHEREAS, on June 1, 2020, the Ohio Department of Transportation (ODOT) temporarily closed the bridge over the Little Miami River along State Route 48, creating a dramatic increase in vehicular traffic through the Village; and,

WHEREAS, with the increase in traffic, it has become difficult for Oversize Vehicles to safely negotiate the required turns in the current local truck route;

WHEREAS, members of the community and Village staff have observed dangerous driving, including property damage and near accidents, by Oversize Vehicles as a result of the road closure;

WHEREAS, Oversize Vehicles have been using Lebanon Road between Dwire Road and Zoar Road which is unsafe for these types of vehicles;

WHEREAS, Village Staff and the Warren County Sheriff's Office are recommending that the eastbound truck route be temporarily altered during said bridge closure to follow the westbound route;

WHEREAS, immediate action is required to direct Oversize Vehicles on a safer route through the Village and in order to preserve the public peace, health, or safety of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, at least a two-thirds of all members elected thereto concurring:

<u>Section 1</u>. That Ordinance 2002-06 is hereby amended to designate the east bound truck route as follows, and more particularly described in Exhibit A, incorporated herein by reference:

- 1. Pike Street;
- 2. Right on High Street;
- 3. Left on Forrest Avenue;
- 4. Right on Mary Ellen Street; and
- 5. Left on Morrow Road

Section 2. That Oversize Vehicles are prohibited on Lebanon Road from Zoar Road south to the Village corporate limits, as more particularly described in Exhibit B, incorporated herein by reference.

<u>Section 3.</u> That Section 1 of this Ordinance shall automatically be repealed on January 1, 2021, or when the State Route 48 bridge is permanently re-opened to the public, whichever is sooner.

Section 4. All other sections in Ordinance 2002-06 inconsistent with this current Ordinance shall remain unaffected.

<u>Section 5.</u> That the Village Administrator is authorized to install signage to reflect the modifications listed herein.

<u>Section 6.</u> That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

<u>Section 7</u>. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

<u>Section 8</u>. That this Ordinance is declared to be emergency legislation, necessary for the immediate preservation of the public peace, health, and safety, which shall be effective upon passage


