Accepting FY23 Tax Rates

Subject:

On July 7, 2021, Council approved Resolution 2022-28 to submit the Fiscal Year 2023 Tax Budget to the County Auditor.

The FY 2023 Tax Budget has been approved and we have received the Official Certificate of Estimated Resources from the County Auditor. The Official Certificate certifies the amount of estimated Property Taxes and Local Government Funds the City is expected to receive next year. I've highlighted those amounts on the Official Certificate (see attached).

We had a 6% increase in estimated property tax revenue from \$188,000 (2022) to \$200,000 (2023). The increase was due to an increase in new construction and the City's overall assessed property values. The assessed property value is estimated to be \$162,777,020 for tax year 2022, collection year 2023. The prior year assessed value was \$152,875,207.

The County Auditor is estimating the city will receive \$30,148 in Local Government funding. This amount increased 24% and is based on the City's 2020 census data. The amount received for the prior year was \$24,418.

Resolution 2022-38 accepts the amounts and rates as determined by the County Budget Commission and certifies them to the County Auditor by the deadline of October 1, 2022.

Subject: Resolution 2022-39 General Fund Transfer – Charter Commission

Additional appropriations are needed for the expenses associated with funding the Charter Commission. The original budget was estimated at \$50,000. On June 16, 2022, Council approved Ordinance 2022-18, supplemental appropriations of \$50,000, to fund the Charter Commission. As of August 31st, the Commission has incurred expenses of nearly \$40,000. We are estimating that an additional \$50,000 will be needed through the end of the year.

I'm requesting Council approve to transfer appropriations from Capital Outlay for the additional amount needed. The 2022 Capital Outlay budget included \$350,000 for the renovation of the Municipal Building 2nd Floor. It has been determined that those improvements will not occur during 2022. Therefore, I'm recommending a transfer from Capital Outlay to Operating Expenses to fund additional estimated expenses for the Charter Commission. The transfer will result in a \$0 net effect to the total appropriations.

AGREEMENT

This AGREEMENT, the effective date of which shall be upon the last date of execution by all parties hereto, by and between the Council of the City of South Lebanon, an Ohio Municipal Corporation, 10 N. High Street, South Lebanon, OH 45065 (the "City"), and The Drees Company, a Kentucky corporation whose mailing address is 211 Grandview Drive, Fort Mitchell, KY, 41017 (the "Developer"), is in accordance with the City's Ordinances and Resolutions, and pursuant to the Approved Construction Drawings (the "Plans") that are on file in the office of the Administrator for the completion of the public and other improvements associated with the waterline extension on Zoar Road (the "Project").

WITNESSETH:

WHEREAS, the Developer proposed to develop a 110-unit residential subdivision to be known as Highmeadow which shall be situated on real property within the City of South Lebanon, County of Warren, State of Ohio, identified as Parcel #'s 17-36-200-035, 17-36-200-036, and 17-36-200-037, and,

WHEREAS, the City desires to install a connection to Warren County Water service on Zoar Road and to extend a City-owned public water main approximately 181 lineal feet from the connection point on Zoar Road to the entrance to the proposed Highmeadow development as per approved plans ("Project"); and,

WHEREAS, the City has contracted for the development of construction plans for the Project and has received a "Permit-to-Install" from the Ohio Environmental Protection Agency (OEPA) for the Project; and

WHEREAS, the Developer has expressed interest in constructing the project in lieu of paying connection fees to the City public water system; and,

WHEREAS, the City and the Developer now desire to enter into this Agreement, the terms and conditions of which are set forth hereinafter.

NOW, THEREFORE IT IS AGREED:

1. The Developer, through a contractor approved by the City (the "Contractor"), agrees to provide all labor and material, with the exceptions listed in paragraph 2, necessary to construct the Project per the construction plans approved by OEPA

on February 11, 2022. This also includes all testing requirements per the plans and City construction specifications.

- 2. The City shall provide to the Contractor the master meter vault and all appurtenances shown on Exhibit "A".
- 3. Prior to commencing work on the Project, the Developer shall provide a copy of the Contractor's Certificate of Insurance naming the City of South Lebanon as an additional insured and a copy of the Contractor's valid certificate from the Ohio Bureau of Worker's Compensation.
- 4. The Developer or Contractor shall provide a performance surety in the amount of 100% of the estimated costs as provided in the attached Exhibit B. The form of said surety shall be approved by the City Solicitor. Upon completion and acceptance of the Project by the City, a one-year maintenance bond or surety equal to 10% of the final construction costs shall be provided to the City. In the event that Developer incurs additional costs, including but not limited to, survey fees and landscape repair, Developer shall provide written notification of the additional cost to construct the Project. Upon notice and acceptance of the additional cost by the City, this Agreement shall be amended to reflect same and the total amount of the project cost shall be credited by the City to the Developer as set forth in paragraph 6 below.
- 5. The City water connection fee of \$5,600/each, which were in effect at the time of the commencement of the City's approval of the Highmeadow development, shall be used in the calculation of tap-in credits as a result of this Agreement.
- 6. Upon the receipt of properly documented project costs at listed in Exhibit B, as may be amended, the City shall credit the Developer of the Highmeadow development for water sewer connections fees for the Highmeadow development.
- 7. Upon completion of the Project and all credit being applied to water connection fees per paragraph 6 above, all future tap-in fees shall be paid for by applicant at the time of issuance of building permit.
- 8. <u>Completion Dates</u>. All work associated with the installation of the waterline along Zoar Road shall be completed within ninety (90) days of the execution of this Agreement and the recording of the required easements, whichever is later. In the event that Developer does not adhere to the completion dates as set forth above, the City may complete the project and the credit given to the Developer for the

water connection fees shall be reduced by the amount expended by the City in order to complete the project.

- 9. <u>Indemnification</u>. The Developer agrees to indemnify and hold the City harmless from and against all suits, liens or claims that may be based upon any injury to any person or property or any mechanic's liens that may be filed as a result of this Project. In the event of any mechanic's liens or other liens are filed as a result of this Project, the Developer agrees that it shall secure the removal of any such lien within thirty (30) days of the filing of any such lien.
- 10. <u>Maintenance of Traffic.</u> The Developer shall be responsible for the maintenance of traffic related to this Project. Any required traffic control plans shall be submitted to and approved by the City of South Lebanon.
- 11. <u>Agreement Amendments</u>. This Agreement shall not be amended or otherwise modified unless such amendment or modification is in writing and signed by all parties.
- 12. <u>Severability</u>. Should any portion of this Contract be deemed unenforceable by any administrative or judicial officer or tribunal of competent jurisdiction, the balance of this Agreement shall remain in full force and effect unless revised or terminated pursuant to any other section of this Agreement.
- 13. <u>Waiver</u>. No waiver by either party of any breach of any provision of this Contract shall be deemed to be a further or continuing waiver of any breach of any other provision of this Contract. The failure of either party at any time or times to require performance of any provision of this Contract shall in no manner affect such party's right to enforce the same at a later time.



III. DELINQUENT ACCOUNTS.

The bill for any service rendered for water, sanitation, and sewer service shall be paid by the 22nd of each month following the billing thereof, and if not paid within that time, a penalty of ten percent (10%) shall be added thereto. If the 22nd of the month falls on a weekend or a holiday, the bill shall be paid by the first business day following the 22nd. If the delinquent bill is not paid within fourteen (14) days of the date it was due, together with the penalty thereon, the Utilities Clerk shall cause the service to be discontinued; and it shall be resumed only on payment by the customer of the full amount of the account, plus an additional fifty dollars (\$50.00) reconnection fee. In any event, no applicant with a delinquent utility account with the City of South Lebanon shall be approved for water service until any and all delinquent amounts to the City of South Lebanon Utility Department are paid in full.



Subject:	Memorial Park Landscaping

As you may have noticed, the work on the Memorial Park drainage project is progressing quickly. After the excavation portion is completed, the landscaping portion is next. I have received a quote from Creech's Landscaping in the amount of \$32,379.50 to do the landscaping work including the rock & soil work that was originally in the excavation contract.

Due to the sequence of construction, it makes more sense for the landscaper to do this work. Therefore, there will be some items that the O'Heill Site Solutions, the excavation contractor will non-perform.

There was \$90,000 budgeted for this project. With this additional amount, the total will be near \$102,000. I would recommend moving \$12,000 from the upstairs renovation to this project.
