14. COMMUNICATIONS & REPORTS

Mayor Smith

a. Has reached out to the individual who designed the street lighting at the intersection of Mason-Morrow-Millgrove Road. The gentleman will be meeting

with Mayor Smith and Haddix to discuss what he would recommend for the intersection of Pike Street and Main Street. We do have all of the materials and we are going to reach out to the contractors who service our poles and see if there is anything we can work out.

Fiscal Officer Tina Williams

a. There will be a Finance Committee meeting on Wednesday, November 30, 2022 at 8:30 a.m. here at the Municipal Building.

Administrator Jerry Haddix

- a. Stated that Larry Easterly has passed his probation period.
- b. OPWC Integrating Committee for District 10 met yesterday, November 16, 2022. We had 2 projects that did not get funded this past summer; apparently, they have located some more funds for projects that were not funded, and we were able to get our projects (Morrow Road and Forest Avenue) added to the list to be funded. Both projects total approximately 1.4 million with \$960,000.00 funded from OPWC. This will be for reconstructing Morrow Road from Mary Ellen Street to Mary Lane and then Forest Avenue from High Street to Section Street.
- c. The Pike Street bridge that Warren County got funded will not be constructed until probably 2024.
- d. The Warren County Commissioners meeting for the Lenig Annexation Tuesday, November 29, 2022 at 9:05 a.m.
- e. Tim Abbott, formerly with Duke Energy, now with Energy Alliances, an energy broker, has looked over the City's gas bills and we are currently paying Duke over \$1.00 per CCF, he was able to find us a 3 year lock in for under .75 per CCF. Based on our current rate this will save us roughly \$1,500.00 a year over 3 years. You have 24 hours to respond to the lock in rate so it could be slightly different from what was given earlier. A motion is needed to authorize Haddix to enter into an agreement with Energy Alliances.

A motion was made to allow Haddix to lock in an updated gas rate with Energy Alliances by Allen, seconded by Burke, all yeas.

Discussion ensued between Council members with Mayor Smith adding that the group will be brought in to make a presentation.

Discussion continued regarding an aggregate utility system for the residents of South Lebanon to which Meier stated that it would have to be on the ballot.

- f. The Vibrant Oil project at 48/Mason-Morrow-Millgrove Road will now be completing their project in phases, so the Warren County Planning Commission is going to have to revisit their site plan on the evening of Tuesday, November 29, 2022.
- g. The Pauline Drive Storm/Sewer project bid opening is December 6, 2022; the estimate is \$409,000.00.
- h. Stated that the flags will be taken down once the lift truck is available, it should have been delivered Monday however there were scheduling issues with the vendor.

Assistant Administrator Jeff Boylan

- a. When asked by Mayor Smith if the City would be able to get another truck he stated he was unsure.
- b. Investigating purchasing a scissor lift that would attach to the Bobcat and allow us to not need to rent a bucket truck.

Solicitor Andrew Meier

a. Thanked the Council for approving the contract and increasing the salary.

Sgt. Corey Adams

- a. Gave some information on a fraud complaint and reminded everyone to be vigilant.
- b. Williams asked about spam/phishing emails and if the Sheriff's Office does get involved; a conversation ensued.
- c. There was some discussion of the Flock camera video system and recent cases it has been used in.
