ORDINANCE 2023-19, AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF NOT TO EXCEED \$8,250,000 OF TAX INCREMENT REVENUE REFUNDING BONDS, SERIES 2023 (RIVERSIDE PROJECT) OF THE CITY OF SOUTH LEBANON, OHIO, UNDER SECTION 5709.40 ET SEQ. Dean Spoor with Thompson Hine, via Zoom, explained the reasonings behind the change from an amendment to a new cooperative agreement.
