A RESOLUTION APPROVING AND AUTHORIZING MAYOR AND DIRECTOR OF FINANCE TO EXECUTE ADDENDUM NO. 2 TO THE AGREEMENT WITH THE WARREN COUNTY SHERIFF AND THE WARREN COUNTY BOARD OF COMMISSIONERS FOR POLICE PROTECTION IN THE CITY OF SOUTH LEBANON FOR THE CALENDAR YEAR 2024 AND DECLARING AN EMERGENCY

WHEREAS, providing public safety is one the most critical functions of local municipal government; and,

- **WHEREAS**, the City, the Sheriff and the Warren County Board of Commissioners entered into an Agreement for Police Protection dated August 24, 1998, and the Agreement was thereafter amended in 2002, 2006, 2008, 2012, 2015 plus the most recent amendment being for the calendar year 2019 per Resolution No. 2018-70; and,
- WHEREAS, the City, the Sheriff, and the Warren County Board of Commissioners, have approved an addendum to the Agreement to for Police Protection with the only modifications being a change in the cost for the 2024 services, all other terms and conditions shall remain the same; and,
- WHEREAS, the City has requested an additional Deputy Sheriff be assigned to the South Lebanon Post of the Sheriff's office and the Sheriff has provided a cost for said additional Deputy; and,
- **WHEREAS**, immediate action is needed for the purpose of providing added police protection to the City for the safety of its citizens, and such action is necessary in order to preserve the public peace, health, or safety of the City.
- **NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:
- <u>Section 1</u>. That the Council approves and authorizes the Mayor and Director of Finance to execute Addendum No. 2 to the Police Protection Agreement for police protection in the City of South Lebanon for the calendar year 2024, a copy of which is attached hereto.
- <u>Section 2</u>. Authorizing the Director of Finance to pay invoices relating to the said Addendum once billed and received for police protection services for calendar year 2024 without further action of Council.
- <u>Section 3</u>. The recitals contained in the Whereas clauses set forth above are incorporated by reference herein.
