

**VILLAGE OF SOUTH LEBANON, OHIO
ORDINANCE NO. 2021-8**

**AN ORDINANCE APPROVING THE APPOINTMENT OF PETRINA D. WILLIAMS
TO THE POSITION OF ASSISTANT FISCAL OFFICER AND ESTABLISHING
COMPENSATION, AND DECLARING AN EMERGENCY**

WHEREAS, in accordance with Ohio Revised Code (ORC) § 733.262(A), the Village Council established the position of Fiscal Officer pursuant to Ordinance No. 2013-12, dated June 19, 2003; and,

WHEREAS, in accordance with ORC § 733.262(D), the Village Council established the position of Assistant Fiscal Officer pursuant to Ordinance No. 2016-11, dated August 30, 2016; and,

WHEREAS, the current Fiscal Officer for the Village has given notice to the Village that she intends on terminating her employment as of May 7, 2021; and,

WHEREAS, the Village Council desires to immediately employ an Assistant Fiscal Officer who will transition into the position of Fiscal Officer effective May 8, 2021, with the assistance of the current Fiscal Officer; and,

WHEREAS, per ORC § 733.262(D), the Mayor has appointed Petrina D. Williams to the position of Assistant Fiscal Officer effective April 28, 2021, and, upon termination of the current Fiscal Officer's employment, to the position of Fiscal Officer effective May 8, 2021; and,

WHEREAS, said appointment does not become effective until it is approved by a majority of the members of Village Council; and,

WHEREAS, immediate action is needed for the purpose of the Village having a Fiscal Officer, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

Section 1. That the Village Council approves the appointment of Petrina D. Williams to the position of Assistant Fiscal Officer of the Village of South Lebanon and, immediately upon termination of the current Fiscal Officer's employment on May 8, 2021, to the position of Fiscal Officer of the Village of South Lebanon.

Section 2. That the Village Council sets for compensation for this position at \$70,000.00 per year.

Section 3. That the Village Council hereby waives the residency requirements as stated in ORC § 733.262 for this position.

Section 4. That, per Ordinance No. 2021-7, the Village Council does hereby allow the inclusion of Petrina D. Williams' prior service time with any State of Ohio agency and other local governments within the State of Ohio for the purposes of vacation accrual.


Section 5. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.


Section 6. That this Ordinance is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Ordinance shall be in full force and effective immediately upon its passage.

Section 7. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
