

**VILLAGE OF SOUTH LEBANON, OHIO
ORDINANCE NO. 2021-5**

**AN ORDINANCE DESIGNATING COMPENSATION OF ASSISTANT VILLAGE
ADMINISTRATOR TO SPECIFIC VILLAGE FUNDS, AND DECLARING AN
EMERGENCY**

WHEREAS, the Council adopted Ordinance 2016-17 designating the specific Village fund(s) from which certain Village officers' and employees' compensation would be paid; and,

WHEREAS, per Ordinance No. 2020-24, the position of Assistant Village Administrator was created by the Village Council and said position has recently been filled; and,

WHEREAS, upon review of the Assistant Village Administrator's duties and responsibilities, it was determined that the Water and Sanitary Sewer Funds should be charged for 30% of his salary respectively; and,

WHEREAS, immediate action is required to move certain employees compensation to specific Village funds, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, at least two-thirds of all members elected thereto concurring:

Section 1. That the following appointed employee of the Village of South Lebanon, Ohio shall be paid from the respective Village fund as indicated herein:

| Assistant Village Administrator | General – 40% Water – 30% Sewer – 30% |


Section 2. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.


Section 3. That this Ordinance is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.

Section 4. That it is found and determined that all formal actions of the Council concerning and relating to passing this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
