ORDINANCE NO. 2022-23

**AN ORDINANCE CREATING TEMPORARY POSITIONS IN THE PUBLIC WORKS  
DEPARTMENT AND ESTABLISHING COMPENSATION, AND DECLARING AN  
EMERGENCY**

**WHEREAS**, due to an expanding workload within the City Public Works Department, the City requires additional temporary employees in the Department; and,

**WHEREAS**, it is necessary to create temporary positions and establish compensation due to complete upcoming projects planned for 2022 and future years; and,

**WHEREAS**, immediate action is required to ensure the continuity of trained personnel in the City Public Works Department in order to preserve the public peace, health, or safety of the City.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of South Lebanon, Ohio, at least two-thirds of all members elected hereto concurring:

**Section 1.** That three (3) temporary Laborer positions in the Public Works Department are hereby created.

**Section 2.** That compensation pay range for said position shall be equal to Pay Grade 1 as set forth in the City of South Lebanon Compensation Plan.

**Section 3.** The City Administrator shall advertise for the forthcoming temporary position of Laborer, review applications, and select qualified applicants subject to the Mayor's approval.

**Section 4.** That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

**Section 5.** That this Ordinance is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Ordinance shall be in full force and effective immediately upon its passage.

**Section 6.** That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
