

**CITY OF SOUTH LEBANON, OHIO  
RESOLUTION 2022-39**

**A RESOLUTION APPROVING AND AUTHORIZING THE FISCAL OFFICER  
TO TRANSFER FUNDS FOR FISCAL YEAR 2022, AND DECLARING AN  
EMERGENCY**

**WHEREAS**, the Fiscal Officer has advised Council that funds need to be transferred from and to accounts at the legal level of budgetary control as set by Council Ordinance 2022-09 for fiscal year 2022; and,

**WHEREAS**, the transfer is needed for the purpose of additional expenses associated with funding the Charter Commission, which was established as a result of the May 2022 election, is a separate public body, but that does not have its own source of funding and, as a result, requires funding from the City of South Lebanon; and

**WHEREAS**, immediate action is required to have adequate appropriations for current expenses and other expenditures of the City of South Lebanon, State of Ohio, for the period of January 1, 2022 through December 31, 2022, and such action is necessary in order to preserve the public peace, health, safety or welfare of the City.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of South Lebanon, Ohio, at least two-thirds of the current members elected thereto, concurring:

**Section 1.** The Council approves and authorizes the Fiscal Officer to transfer the following funds from and to the following accounts:

**General Fund -1000**

From: Capital Improvements – Capital Outlay (Account: 1000-800-530)	(\$ 50,000.00)
To: Other General Government – Operating Expenses (Account: 1000-790-349-1014)	\$ 50,000.00


**Section 2.** That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

**Section 3.** That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.

**Section 4.** That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.




