A RESOLUTION APPROVING AND AUTHORIZING MAYOR AND FISCAL OFFICER TO EXECUTE AN ADDENDUM TO THE AGREEMENT WITH THE WARREN COUNTY SHERIFF AND THE WARREN COUNTY BOARD OF COMMISSIONERS FOR POLICE PROTECTION IN THE CITY OF SOUTH LEBANON FOR THE CALENDAR YEAR 2023 AND DECLARING AN EMERGENCY

WHEREAS, providing public safety is one the most critical functions of local municipal government; and,

WHEREAS, the City, the Sheriff and the Warren County Commissioners entered into an Agreement for Police Protection dated August 24, 1998, and the Agreement was thereafter amended in 2002, 2006, 2008, 2012, 2015 plus the most recent amendment being for the calendar year 2019 per Resolution No. 2018-70; and,

WHEREAS, the Sheriff desires to enter into an Addendum to the said Agreement for Police Protection with the City for the calendar year 2023, thereby amending the Agreement for Police Protection with the only modifications being a change in the cost for the 2023 services, all other terms and conditions shall remain the same; and,

WHEREAS, immediate action is needed for the purpose of providing police protection to the City for the safety of its citizens, and such action necessary in order to preserve the public peace, health, or safety of the City.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

<u>Section 1</u>. That the Council approves and authorizes the Mayor and Fiscal Officer to execute the Addendum to the Police Protection Agreement for police protection in the City of South Lebanon for the calendar year 2023, a copy of which is attached hereto.

<u>Section 2</u>. Authorizing the Fiscal Officer to pay invoices relating to the said Addendum once billed and received for police protection services for calendar year 2023 without further action of Council.

<u>Section 5</u>. That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.
