## A RESOLUTION AUTHORIZING THE MAYOR AND FISCAL OFFICER TO ENTER INTO AN AGREEMENT WITH LEBANON FORD FOR THE PURCHASE OF A FORD F-150 PICKUP TRUCK, AND DECLARING AN EMERGENCY

- **WHEREAS**, the City staff has recommended the purchase of a 2024 model Ford F-150 pickup truck to replace a 2008 Ford F150 pickup; and,
- **WHEREAS**, Lebanon Ford submitted a quote for \$32,895.00 for purchasing a Ford F-150 pickup truck; and,
- WHEREAS, Cronin Ford North also submitted a bid for a 2023 Ford F-150 pickup truck for a total of \$35,085.00; and,
- **WHEREAS**, Valley Chevrolet has the Ohio State bid award for the comparable Chevrolet Silverado 1500 for a base price of \$53,885.00; and,
- WHEREAS, the City staff recommends purchasing a Ford F-150 from the low bid of \$32,895.00 from Lebanon Ford; and,
- WHEREAS, due to the continued shortage of the availability of new trucks, ordering this vehicle early in the year allows the best chance of receiving one later this year, so immediate action is required and such action is necessary in order to preserve the public peace, health, safety or welfare of the city,
- **NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of South Lebanon, at least two-thirds of all members elected thereto concurring:
  - <u>Section 1</u>. That the Mayor and Fiscal Officer are hereby authorized to issue a purchase order to Lebanon Ford in the amount of \$32,895.00 for the purchase of a Ford F-150 pickup truck.
  - <u>Section 2</u>. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.
  - <u>Section 3</u>. That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the

public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.
