A RESOLUTION APPROVING AND AUTHORIZING MAYOR AND DIRECTOR OF FINANCE TO EXECUTE AMENDMENT #3 TO AGREEMENT WITH MCGILL SMITH PUNSHON INC. FOR THE MASON-MORROW-MILLGROVE ROAD WATERLINE EXTENSION PROJECT, AND DECLARING AN EMERGENCY

- **WHEREAS**, on January 21st, 2021, the then-Village Council passed Resolution No. 2021-3 and entered into an agreement with McGill Smith Punshon Inc. ("Engineer") for the design of the Mason-Morrow-Millgrove Road Waterline Extension Project in the amount of \$46,650.00; and.
- **WHEREAS**, on March 3rd, 2022, the City Council passed Resolution No. 2022-08 and approved Amendment #1 to the Agreement with McGill Smith Punshon Inc. ("Engineer") for the additional field location and design work on the Mason-Morrow-Millgrove Road Waterline Extension Project in the amount not to exceed \$50,050.00; and,
- **WHEREAS**, on March 2nd, 2023, the City Council passed Resolution No. 2023-12 and approved Amendment #2 to the Agreement with McGill Smith Punshon Inc. ("Engineer") for the additional design work on the Mason-Morrow-Millgrove Road Waterline Extension Project in the amount not to exceed \$77,050.00; and,
- **WHEREAS**, the Engineer has incurred additional expenses during the construction phase of the Project above the current contract price; and,
- WHEREAS, the Engineer has submitted a proposal for additional engineering services which will result in a not to exceed cost of \$79,554.86 which is a net increase of \$2,504.86 from the current contract price; and,
- WHEREAS, immediate action is required to approve said amendment to ensure the prompt payment to the Engineer and allow for the closeout of the Project and such action is necessary in order to preserve the public peace, health, safety or welfare of the City.
- **NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of South Lebanon, at least two-thirds of all members elected thereto concurring:
- <u>Section 1</u>. Approve Amendment #3 with McGill Smith Punshon Inc., a copy of which is attached hereto, and further authorize the Mayor and Director of Finance to execute an Amendment on behalf of the City.
- <u>Section 2.</u> That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

- <u>Section 3</u>. That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev.
