

**CITY OF SOUTH LEBANON, OHIO
RESOLUTION NO. 2024-39**

**A RESOLUTION APPROVING AND AUTHORIZING MAYOR AND DIRECTOR OF
FINANCE TO EXECUTE AN ADDENDUM TO THE AGREEMENT WITH THE
WARREN COUNTY SHERIFF AND THE WARREN COUNTY BOARD OF
COMMISSIONERS FOR POLICE PROTECTION IN THE CITY OF SOUTH
LEBANON FOR THE CALENDAR YEAR 2025**

WHEREAS, providing public safety is one of the most critical functions of local municipal government; and,

WHEREAS, the City, the Sheriff and the Warren County Commissioners entered into an Agreement for Police Protection dated August 24, 1998, and the Agreement was thereafter amended in 2002, 2006, 2008, 2012, 2015, 2019 plus the most recent amendment being for the calendar year 2024 per Resolution No. 2024-14; and,

WHEREAS, the Sheriff desires to enter into an Addendum to the said Agreement for Police Protection with the City for the calendar year 2025, thereby amending the Agreement for Police Protection with the only modifications being a change in the cost for the 2025 services, all other terms and conditions shall remain the same; and,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of South Lebanon, Ohio, at least a majority of all members elected thereto concurring:

Section 1. That the Council approves and authorizes the Mayor and Director of Finance to execute the Addendum to the Police Protection Agreement for police protection in the City of South Lebanon for the calendar year 2025, a copy of which is attached hereto.


Section 2. Authorizing the Director of Finance to pay invoices relating to the said Addendum once billed and received for police protection services for calendar year 2025 without further action of Council.

Section 3. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.




