

**CITY OF SOUTH LEBANON, OHIO
ORDINANCE 2025-21**

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION ORDINANCE 2025-05 FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF SOUTH LEBANON, STATE OF OHIO, FOR THE PERIOD OF JANUARY 1, 2025 THROUGH DECEMBER 31, 2025, AND DECLARING AN EMERGENCY

WHEREAS, the Council adopted Ordinance 2025-05 on March 6, 2025, making appropriations for current expenses and other expenditures for the period of January 1, 2025 through December 31, 2025; and,

WHEREAS, the annual appropriations shall be amended to increase appropriations in the General Fund by \$12,220 for severance compensation of unused leave balances owed to the City Administrator upon retirement; and,

WHEREAS, the annual appropriations shall be amended to increase appropriations in the River’s Crossing TIF Fund by \$9,100 to allow for distribution of the actual amount of service payments received; and,

WHEREAS, the annual appropriations shall be amended to increase appropriations in the Riverside Crossing TIF Fund by \$100,100 to allow for distribution of the actual amount of service payments received; and,

WHEREAS, immediate action is required to make appropriations for current expenses and other expenditures of the City of South Lebanon, State of Ohio, for the period of January 1, 2025 through December 31, 2025, and such action is necessary in order to preserve the public peace, health, safety or welfare of the City.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of South Lebanon, at least two-thirds of all members elected thereto concurring:

Section 1. That, to provide for the current expenses and other expenditures of the said City of South Lebanon, for the period of January 1, 2025 through December 31, 2025, the following sums are hereby set aside and appropriated as follows:

General Fund -1000

Personal Services

From: \$560,925 To: \$573,145

River’s Crossing TIF Fund - 2907

Development Incentives

Operating Expenses

From: \$592,840 To: \$601,940

Riverside TIF Fund - 2909

Development Incentives

Debt Service

From: \$689,895.70 To: \$739,745.70


Ordinance 2025-21 Amended Appropriations

Section 2. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 3. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure in accordance with Section 731.30 of the Ohio Revised Code for the immediate preservation of the public peace, health, safety, and general welfare; and this Ordinance shall be in full force and effective immediately upon its passage.




