AN ORDINANCE AMENDING ORDINANCE 2011-14 AND FIXING THE RATES FOR WATER USAGE AND DECLARING AN EMERGENCY

WHEREAS, the Council adopted Ordinance No. 2006-01 fixing the rates for water usage in the Village; and,

WHEREAS, the Council adopted Ordinance No. 2011-14 thereby amending Sections IA, IIA, III, and IV of Ordinance 2006-01 to establish new water usage rates; and,

WHEREAS, a rate study was performed by an independent consultant that substantiates the imminent need to amend the current water usage rates by establish new rates in order to sustain the Water System in the Village; and,

WHEREAS, immediate action is required to amend the current water usage rates in order to preserve the public peace, health, safety and general welfare of the Village.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Lebanon, at least two-thirds of all members elected thereto concurring:

<u>Section 1</u>. That Village Ordinance No. 2011-14 is hereby amended to the extent that the following water usage rates shall be effective on the following dates:
