RESOLUTION NO. 2014-06

A RESOLUTION AUTHORIZING THE MAYOR AND FISCAL OFFICER TO
ENTER INTO AN AGREEMENT WITH CONTRACT SWEEPERS AND
EQUIPMENT TO PROVIDE STREET SWEEPING SERVICES IN 2014

WHEREAS, the Village has solicited proposals for street sweeping services throughout the Village in 2014; and,

WHEREAS, Contract Sweepers and Equipment was recommended by staff as the contractor with the lowest and best price; and,

WHEREAS, funds are available in the Village's 2014 budget for street sweeping services; and,

WHEREAS, immediate action is required to assure timely delivery of public works services and projects in the Village, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

Section 1. That the Council authorizes the Mayor and Fiscal Officer to enter into a contract with Contract Street Sweepers and Equipment to provide an initial street sweeping and six (6) additional monthly street sweepings in 2014.

Section 2. That the street sweeping shall be limited to streets with curb and curb and gutter only.

Section 3. That the Council is acting in its administrative capacity in adopting this Resolution.

Section 4. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 5. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were

adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
