RESOLUTION NO. 2014-10**

**A RESOLUTION REAPPOINTING GARY VIDMAR AS SOUTH LEBANON
VILLAGE ADMINISTRATOR AND APPROVING AND AUTHORIZING THE
MAYOR AND FISCAL OFFICER TO EXECUTE AN EMPLOYMENT AGREEMENT
FOR THE TERM OF MARCH 31, 2014 THROUGH MARCH 31, 2015**

WHEREAS, the Council passed Resolution No. 2013-13 on March 28, 2013, confirming the appointment of Gary Vidmar as the Village Administrator, and the Mayor and Fiscal Officer executed an Employment Agreement with Gary Vidmar as authorized by said Resolution (initial Employment Agreement); and,

WHEREAS, the Village Council passed Ordinance No. 2013-05 on April 22, 2013, waiving the residency requirement of the person who fills the position of the Village Administrator in the Village of South Lebanon; and,

WHEREAS, Art. 1, Sec. 1.01 of the initial Employment Agreement provided that the Mayor with the approval of at least a majority of the Village Council may elect to renew the term of Gary Vidmar's Employment Agreement up to four (4), one (1) year terms, however, the term of the employment agreement expired on March 31, 2014 without executing an extension due to the legislation necessitating three separate readings; and,

WHEREAS, the Council now desires to re-appoint Gary Vidmar as the South Lebanon Village Administrator and enter into an Employment Agreement for a new term effective March 31, 2014 through March 31, 2015.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, Ohio, at least a majority of all members elected thereto concurring:

Section 1. That the Council approves the attached Employment Agreement reappointing Gary Vidmar as the South Lebanon Village Administrator for the term of March 31, 2014 through March 31, 2015.

Section 2. That the Mayor and Fiscal Officer are hereby authorized to execute the attached Employment Agreement.

Section 3. That the Council is acting in its administrative capacity in adopting this Resolution.

Section 4. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 5. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were passed in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
