A RESOLUTION APPROVING AND FURTHER AUTHORIZING MAYOR AND FISCAL OFFICER TO EXECUTE A SOFTWARE, HOSTING AND MAINTENANCE AGREEMENT WITH E-GOV LINK

WHEREAS, the Village's website was designed several years ago and much of its content is outdated and stale, when the design and content organization of the Village's website is paramount to positive user experience for citizens, non-citizens, and businesses seeking information about the Village's rich history and its services; and,

WHEREAS, Staff obtained proposals for redesign, hosting and maintenance of the Village's website and has recommended E-Gov Link as the lowest and best proposal for the redesign, hosting and maintenance of a website citizen request management software for the Village, and optional additions of structured data; and,

WHEREAS, the Council desires to enter into an agreement with E-Gov Link for the redesign and content migration of the Village's Website, annual hosting and maintenance of the Village Website, plus a structured data software package with five features.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, Ohio, at least a majority of all members elected thereto concurring:

Section 1. That the Council approves and authorizes the Mayor and Fiscal Officer to execute the Software, Hosting and Maintenance Agreement, attached hereto, subject to the Village Solicitor approving as to form.

Section 2. That the Council is acting in its administrative capacity in adopting this Resolution.

Section 3. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 4. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were

adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
