ORDINANCE NO. 2016-17

AN ORDINANCE RESCINDING ORDINANCE 2012-13 AND DESIGNATING
COMPENSATION OF CERTAIN VILLAGE OFFICERS AND EMPLOYEES TO
SPECIFIC VILLAGE FUNDS, AND DECLARING AN EMERGENCY

WHEREAS, the Council adopted Ordinance 2012-13 designating the specific Village fund from which certain Village officers' and employees' compensation would be paid; and,

WHEREAS, pursuant to the recommendations of the State of Ohio Auditor and the Village Finance Committee, it is necessary to re-designate the specific Village fund from which certain Village officers' and employees' compensation will be paid; and,

WHEREAS, immediate action is required to move certain employees compensation to specific village funds, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, at least two-thirds of all members elected thereto concurring:

Section 1. That Ordinance 2012-13 is hereby rescinded.

Section 2. That the following appointed or elected officers and employees of the Village of South Lebanon, Ohio shall be paid from the respective Village fund as indicated herein:

Section 3. That the Council is acting in its administrative capacity in passing this Resolution.

Section 4. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 4. That this Ordinance is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.

Section 5. That it is found and determined that all formal actions of the Council concerning and relating to passing this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


