## VILLAGE OF SOUTH LEBANON, OHIO ORDINANCE NO. 2016- 18

## AN ORDINANCE AMENDING ORDINANCE 2012-14 AND FIXING THE RATES FOR WATER USAGE, AND DECLARING AN EMERGENCY

WHEREAS, the Village Council adopted Ordinance No. 2012-14 fixing the rates for water usage in the Village and setting water usage rates from 2012 through calendar year 2016; and,

WHEREAS, this Council desires to continue the calendar year 2016 water rates until the recently authorized water rate study is completed and recommendations are made to this Council; and,

WHEREAS, immediate action is required to assure that the water rates are in effect on January 1, 2017, in order to preserve the public peace, health, safety and general welfare of the Village.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

<u>Section 1</u>. That Village Ordinance No. 2012-14 is hereby amended to the extent that the following water usage rates shall be effective on the following dates:

<u>Section 3</u>. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

<u>Section 4.</u> That this Ordinance is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Ordinance shall be in full force and effective immediately upon its passage.

<u>Section 5.</u> That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
