RESOLUTION NO. 2018-71**

**A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR AND FISCAL OFFICER TO EXECUTE A FISCAL YEAR 2019 (FY2019) COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) APPLICATION IN COOPERATION WITH THE UNION TOWNSHIP BOARD OF TRUSTEES AND FURTHER AUTHORIZING THE VILLAGE ADMINISTRATOR TO PROCESS THE APPLICATION WITHOUT DELAY TO THE WARREN COUNTY OFFICE OF GRANTS ADMINISTRATION, AND DECLARING AN EMERGENCY**

**WHEREAS**, the deadline for FY2019 CDBG applications to be delivered to the Warren County Office of Grants Administration is January 4, 2019; and,

**WHEREAS**, Lebanon Road between Pike Street and Corwin Nixon Boulevard is the boundary line between the Village and Union Township; and

**WHEREAS**, the Village and the Union Township Board of Trustees desire to apply for the said FY2019 CDBG for the rehabilitation of Lebanon Road [extending from Pike Street to Corwin Nixon Boulevard] with the Village acting as the lead applicant; and,

**WHEREAS**, the estimated cost of each Project is as follows:

Project	Village Engineer's Cost Estimate
Lebanon Road Improvements	\$249,944.00

**WHEREAS**, if CDBG funding is awarded, the Union Township Board of Trustees has committed \$20,000 to the construction of this Project; and

**WHEREAS**, immediate action is required for the Village to timely submit a FY2019 CDBG application which is due no later than Wednesday, January 4, 2019, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

**Section 1.** That the Council approves and authorizes the Mayor and Fiscal Officer to execute a FY2019 CDBG application for said Project, a copy of which is attached hereto.

**Section 2.** That the Village Administrator shall process the executed Application to the Warren County Office of Grants Administration without further delay.


**Section 3.** That the Council is acting in its administrative capacity in adopting this Resolution.


**Section 4.** That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

**Section 6.** That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
