RESOLUTION NO. 2015-11

**A RESOLUTION REJECTING ALL BIDS FOR THE LITTLE MIAM RIVER
WATERLINE CROSSING PROJECT AND AUTHORIZING THE VILLAGE'S
PROJECT ENGINEER TO GIVE NOTICE, AND DECLARING AN EMERGENCY**

WHEREAS, the Village advertised for competitive sealed bids for a project known as the Little Miami River Waterline Crossing Project; and,

WHEREAS, on March 26, 2015, as advertised, sealed bid were received, closed, and opened; and,

WHEREAS, the Village desires to reject all sealed bids, and for the Village's Project Engineer to give notice to all bidders that all bids are rejected; and,

WHEREAS, immediate action is required to timely reject all bids in accordance with the invitation to bid, and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of South Lebanon, at least two-thirds of all members elected thereto concurring:

Section 1. The Village Council does hereby reject all bids opened on March 26, 2015 for the Little Miami River Waterline Crossing Project, and does hereby further authorize the Project Engineer to give notice to all bidders that all bids have been rejected.

Section 2. That the Council is acting in its administrative capacity in passing this Resolution.

Section 3. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 4. That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.

Section 5. That it is found and determined that all formal actions of the Council concerning and relating to passing this Resolution were adopted in an open

meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
