

**VILLAGE OF SOUTH LEBANON, OHIO
ORDINANCE NO. 2018-51**

**AN ORDINANCE APPROVING AND ACCEPTING FOR PUBLIC MAINTENANCE
BRANT PLACE, KIBBEY LANE, SUTTON DRIVE AND TROVILLO DRIVE IN
RIVERSIDE PHASE ONE SUBDIVISION, IN THE VILLAGE OF SOUTH
LEBANON AND DECLARING AN EMERGENCY**

WHEREAS, by letter dated September 4th, 2018, the Village Engineer has inspected and verified that the following streets in Riverside Phase One Subdivision have been constructed in compliance with the approved plans and the Village's Subdivision Regulations Sec. 15.20.7 [Requirements for the Construction of Improvements], paragraph 6 [Inspection], to-wit:

Street Name	Street Width	Street Mileage
Brant Place	29.00'	803 l.f.
Kibbey Lane	29.00'	762 l.f.
Sutton Drive	32.00'	1,697 l.f.
Trovillo Drive	29.00'	336 l.f.

WHEREAS, at its meeting held on August 29th, 2018, the Planning Commission of the Village of South Lebanon found that the public streets and appurtenances in Riverside Phase One Subdivision, as described herein, have been constructed in accordance with Sect 15.20.7(6)(a-e) of the Village Subdivision Regulations, subject to completion of punch list items and final approval by the Village Engineer.

WHEREAS, for the Village to commence providing maintenance of the aforementioned streets, and to assure safe passage for the traveling public upon such streets, immediate action is required and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Lebanon, Ohio, at least two-thirds of all members elected thereto concurring:

Section 1. That the Council approves and accepts for public maintenance the herein referenced streets as described herein and illustrated on the attached Exhibit.

Section 2. That the Fiscal Officer certify a copy of this Ordinance to the Warren County Engineer.


Section 3. That the Council is acting in its administrative capacity in passing this Ordinance.


Section 4. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 5. That this Ordinance is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare.

Section 6. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of Council in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.



 - o Kibbey Lane – 762 feet.
 - o Trovillo Drive – 336 feet.
