EMERGENCY RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR, AND DECLARING AN EMERGENCY

The Governing Board of the Village of South Lebanon, Warren County, Ohio, met in regular session on the 20th day of September 2018, at the office of South Lebanon Council Chambers with the following members present:

Mr. James Boerio moved the adoption of the following Resolution:

RESOLVED, by the Governing Board of the Village of South Lebanon, Warren County, Ohio, in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 2019; and

WHEREAS, the Budget Commission of Warren County, Ohio, has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within, the ten mill limitation;

WHEREAS, immediate action is required to submit said acceptance to the Warren County Auditor by the October 1st, 2019 deadline and such action is necessary in order to preserve the public peace, health, safety or welfare of the Village,

THEREFORE BE IT RESOLVED, By the Governing Board of South Lebanon, Warren County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted' and be it further

RESOLVED, That this Resolution is hereby declared to be an emergency measure in accordance with Ohio Rev. Code § 731.30 for the immediate preservation of the public peace, health, safety and general welfare; and, this Resolution shall be in full force and effective immediately upon its passage.

RESOLVED, That there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation as follows:
